- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The standard opening date for fall Chinook in the Priest Rapids Pool is September 1. With Labor Day weekend falling on August 30, 2014, opening two days early will allow for additional angling opportunity. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-310-19500B Freshwater exceptions to statewide rules—Columbia River.

Notwithstanding the provisions of WAC 220-310-195:

- (1) Effective August 30, 2014, one hour before official sunrise, through August 31, 2014, it is permissible to fish for salmon in waters of the Columbia River from Priest Rapids Dam to Wanapum Dam.
- (2) Daily limit six Chinook salmon, up to two adults may be retained as part of the daily limit.
- (3) All other rules for the Columbia River apply.

REPEALER

The following section of the Washington Administrative Code is repealed effective September 1, 2014:

WAC 220-310-19500B Freshwater exceptions to statewide rules—Columbia River.

EMERGENCY RULE ONLY
